3. Objectives

- To protect the rights and interests of the students of the school
- To help parents and teachers to adapt themselves to the changing concepts of parents and teaching.
- To preserve the status of teachers in the school and society
- To promote trust and cooperation between parents and teachers of the school
- To contribute to the overall development of the school

4. Policy

- PTA will be free from any political or religious pressure.
- PTA will offer suggestions in areas of pertaining to administrative matters and day-to-day functioning of the school, and it will not interfere in the decisions of the administration of the school.
- PTA will not harm or work against the interest of the school.

5. Rules

- Right to vote in election of the Executive Committee

Only one parent will be eligible to vote.

Associate members shall have no voting right.


Parent/Teacher Member will have right to get elected.

Membership shall cease on resignation, expulsion, death or removal of names from the Register of Members.

The General Body is authorized to expel a member by passing a resolution by 2/3 rd of the members that are present at the moment of seeking opinion.

All rights, privileges and benefits available to the expelled member shall be forthwith discontinued.

- The PTA will hold the meeting at least once in a Term.
- The quorum of PTA members will be at least 1/10th of the total general members.
- If any member ceases to be a member of PTA, the association may nominate another member in his/her place.
- In case the nomination papers of the members are found invalid, such members can be declared elected unopposed.
- The decision of the Presiding officer will be final and binding on all regarding the election.
- Prior notice and agenda of the meeting should be circulated and displayed in the campus at all important entrances.

6. Authority and functions of the Executive Committee

- To admit members
- To frame rules and regulation subject to this constitution for the proper functioning of the Association
- To call meetings as it when deems fit or is necessary by virtue of the provisions of this constitution
- To organise activities under the auspices of the Association
- To coordinate with liaise with the School Authority/Management and other agencies w.r.t matters concerned under the purview of the Association

7. Teacher Representative

The Teacher Representative (TR) shall be responsible for academic matters concerning classes of representations as per the provisions of the Constitution and shall work under the unanimous decision of the PTA.

8. Meetings

- Any member of the PTA failing to attend three consecutive meetings without any valid reasons/ or fails to provide a reasonable ground for his absence what so ever shall cease to be a member of the EC
- All meetings of the PTA shall be held in school after regular class hours
- A register of records of the meetings and the attendees will be maintained.

9. Emergency Meeting

A three day notice would be required to hold an Emergency Meeting

10. Supremacy

The General Body of The Shri Ram Universal School, Ludhiana shall be the supreme authority and have the right to impose/take away any power and responsibility from any member in case of violation of the constitution.
